#### BA.LL.B (Five Year Course) & LL.B (Three Year Course)

## B.A LL.B:

## (i) Core Compulsory Courses

There shall be thirty eight Core Compulsory Courses which shall include all compulsory subjects and all Compulsory Chineal Courses in legal education as stipulated under Rules of Legal Education, 2008, prescribed by the Bar Council of India.

### (ii) Subject Elective Courses

There shall be Six Subject Elective Courses chosen from amongst the pool of common options as prescribed by the Bar Council of India. The elective courses intend to nurture professional proficiency and skill of law students.

### (iii) Compulsory Foundation Courses

There shall be four Compulsory Foundation Courses. These courses aim at ability enhancement and skill enhancement



#### LL.B:

#### (i) Core Compulsory Courses

There shall be Twenty two Core Compulsory Courses which shall include all compulsory subjects and all Compulsory Clinical Courses in legal education as stipulated under Rules of Legal Education, 2008, prescribed by the Bar Council of India.

#### (ii) Subject Elective Courses

There shall be Six Subject Elective Courses chosen from amongst the pool of common options as prescribed by the Bar Council of India. The elective courses intend to nurture professional proficiency and skill of law students.

#### (iii) Compulsory Foundation Courses

There shall two Compulsory Foundation Courses. The course aim at ability enhancement and skill enhancement

a) The SGPA is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the papers/ courses taken by a student and the sum of the number of credits of all the courses undergone by a student, i.e.

**SGPA** (Si) =  $\Sigma$  (Ci x Gi) /  $\Sigma$ Ci

Where Ci is the number of credits of the first course and Gi is the grade point scored by the student in the ith course. The university shall issue Semester Grade Card to the student.

b) The CGPA is also calculated in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e.

 $CGPA = \Sigma (Ci \times Si) / \Sigma Ci$ 

Where Si is the SGPA of the first semester and Ci is the total number of credits in that semester.

c) The SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.

#### Note:1

- 1) For awarding the class of BALLB third year (first degree of double degree programme) the SGPA of Sem-V & VI will be counted for CGPA
- 2) For awarding the class of BALLB degree year the SGPA of Sem-IX & X will be counted for CGPA
- 3) For awarding the class of LLB II (General degree) the SGPA of Sem-III & IV will be counted for CGPA
- 4) For awarding the class of LLB degree the SGPA of Sem-V & VI will be counted for CGPA

The credit given in the syllabus structure of BALLB & LLB course shall be counted as 64 minutes for each credit.
