### Title of the Practice: "Classes to Masses"

## • Objectives of the Practice:

- 1. Rural as well as Urban communities often face barriers to accessing legal services, which can hinder their ability to seek justice. By providing information about the law increase access to justice for these communities.
- 2. To fulfill the social responsibility of the college towards the urban and rural communities by providing them counseling free of cost to resolve Legal Problems.

## The Context

Our College is located in such area where the poor and needy people were really in need of legal advice and aid to solve their problems. The Classes to Masses initiative by law colleges have a transformative impact on society by providing legal education and awareness to the wider community. This initiative increase legal awareness among the public, helping individuals understand their rights and responsibilities and prevent legal problems. By improving access to justice, the initiative also help address issues of social inequality and promote a more equitable society. Moreover, the initiative strengthens the rule of law by fostering respect and compliance with the law. It can also empower marginalized groups, such as women, minorities, and the economically disadvantaged, by providing them with legal education and awareness, enabling them to assert their rights and advocate for themselves.

#### The Practice

The Classes to Masses initiative carried out by college in following manner-

1. Outreach programs: college organized outreached programs in that college send their faculty members and students to rural areas and other communities to provide legal education and awareness. These programs in the form of

- workshops, seminars, and training sessions, covering various legal topics such as property law, criminal law, consumer protection, and human rights.
- College deputes Para legal volunteers in association with district legal services authority Dhule for giving assistance to the poor and needy people in reference to these problems. In free legal aid clinic the college try to understand the problem of the poor and needy and try to advise him legally.
- 3. Legal helpline: Law colleges set up a legal helpline that the public can access to obtain legal information and advice. The helpline be staffed by law students and faculty members who provide guidance on legal issues and refer cases to legal aid clinics or other legal service providers as needed.
- 4. Legal Aid Clinic Legal aid clinics established by college is an essential component of the legal system and play a critical role in promoting access to justice and providing legal assistance to marginalized communities. One of the primary benefits of legal aid clinics is that they provide free legal services to individuals who cannot afford to hire a lawyer. This ensures that everyone has access to justice, regardless of their financial status. Legal aid clinics also provide legal education and awareness to the public, particularly to marginalized communities who may not have a good understanding of their legal rights and obligations.

#### • Evidence of success:


In the academic year 2021-22 The initiative was implemented successfully by the law college with the help of the staff, para-legal volunteers, and legal aid cells. The staff members of the law college visited several rural areas to conduct lectures on various legal issues, including land laws, labour laws, and environmental laws. The lectures were conducted in a language that the rural population could understand, and the participants were encouraged to ask questions and clarify their doubts.

In addition to the lectures, para-legal volunteers were also involved in the initiative to provide legal information to the rural population. The volunteers were trained to provide basic legal information on various legal issues and to refer complex cases to legal aid cells. Legal aid cells were also set up to disseminate legal information and provide legal assistance throughout the year.

Finally, a legal aid helpline was established to provide legal advice and assistance to the rural population through a helpline. The helpline received calls from the rural population on various legal issues, and the staff at the legal aid helpline provided legal advice and referred complex cases to legal aid cells.

## Problems encountered and resources required

The college has set up a legal Aid cell on its campus to provide utmost privacy to the persons and their privacy. The college organizes Workshops Lectures and Camps where the monetary resources of the college are utilized. The institute provides the expenses for their traveling and convenience.

# Title of the Practice: "Jagar Sanvidhanacha" ("Know our Constitution")

# Objectives of the Practice

- 1. The initiative aims to increase people's knowledge and understanding of the Constitution, its key features, and the fundamental rights and duties enshrined in it.
- 2. The initiative seeks to promote the principles of democracy and citizenship by educating people on their roles and responsibilities in a democratic society.

#### • The Context

#### • The Practice:

### • Evidence of Success:

### Problems encountered, and Resources required:

The primary issue faced in implementing this activity was approaching the academic institutes and Society and getting them on board to complete this activity. It took a lot of effort from the faculty to convince the participating entities. Explaining the law in general Language was difficult; teachers had to make extra efforts to conduct the session in a generalized format. The technicalities were best avoided by making brief explanations.

Conducting educational activities, legal aid clinics, and a legal helpline requires significant resources, including financial and human resources. Limited resources can affect the scope and effectiveness of the initiative. Rural and underprivileged areas

may have limited infrastructure and communication facilities, which can make it challenging to reach out to the target audience. Despite efforts to promote the initiative, some people may not be interested in participating in the educational activities or legal aid clinics, which can affect the reach and impact of the initiative.
